WHEREAS, the City of Jonesboro advertised and received bids or (request for proposals) for the purchase and installation of playground equipment at North Main, William Evans, Fairview, and Joe Mack Campbell Parks on September 12, 2003 for the CDBG Grant Program and the State of Arkansas Department of Parks and Tourism; and

WHEREAS, the request for proposals as set out on the attached documents was submitted by various contractors and the equipment was rated and ranked by the Parks Department Staff; and

WHEREAS, we received the bid proposal (RFP) from Gridline Skate Parks on July 25, 2003 of \$150,000 for the skate park at Allen Park; and

WHEREAS, the Parks Committee recommended on September 24, 2003 approval of awarding a contract (RFP or request for proposal) submitted by the bidders as set out herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS:

THAT, the request for proposals be accepted and further agreed as set out in the documents attached hereto, and is hereby approved; and that the Mayor and City Clerk be authorized to sign the Request for Proposals.
