WHEREAS, the City of Jonesboro desires to accept the low bid and enter into a contract for the construction of the Turtle Creek Greenway Phase 1 - Pedestrian Bridge - Job No. 2009:33;

WHEREAS, the low bidder and the firm selected for the construction of the Turtle Creek Greenway Phase 1 - Pedestrian Bridge - Job No. 2009:33 is Tridant Builders, Inc.;

WHEREAS, Tridant Builders, Inc. has bid \$178,000.00 for the construction of the Turtle Creek Greenway Phase 1 - Pedestrian Bridge - Job. No. 2009:33;

WHEREAS, the funding for the execution of the contract shall come from appropriated grant funds - 2007 Safe Routes to School and compensation shall be paid in accordance with the contract documents.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1. That the City of Jonesboro shall accept the low bid and enter into a contract with Tridant Builders, Inc. in the amount of bid \$178,000.00 for the construction of the Turtle Creek Greenway Phase 1 - Pedestrian Bridge - Job. No. 2009:33;

Section 2. The funding for the execution of the contract shall come from appropriated grant funds - 2007 Safe Routes to School and compensation shall be paid in accordance with the contract documents.
