A RESOLUTION TO THE CITY COUNCIL OF JONESBORO, ARKANSAS AUTHORIZING THE OFFER AND ACCEPTANCE TO PURCHASE ADDITIONAL RIGHT-OF-WAY AT 1099 CREATH AVENUE FOR THE PURPOSE OF THE CONSTRUCTING AND MAINTAINING ROADWAY IMPROVEMENTS

WHEREAS, the City of Jonesboro, Arkansas desires to purchase the following described right-of-way for the purpose of constructing and maintaining roadway improvements:

PART OF LOTS 6 & 7, BLOCK 1 OF PATRICK'S 1ST ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF LOT 7, BLOCK 1 OF PATRICK'S 1ST ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE NORTH 89°42'29" EAST, ALONG THE NORTH LINE OF SAID BLOCK 1, 149.74 FEET; THENCE SOUTH 00°49'44" WEST, LEAVING SAID NORTH LINE, 10.84 FEET; THENCE NORTH 55°00'12" WEST, 10.41 FEET; THENCE NORTH 89°45'48" WEST, 141.12 FEET; THENCE NORTH 01°01'17" EAST, 3.53 FEET TO THE POINT OF BEGINNING, CONTAINING 657 SQ. FT., MORE OR LESS, SUBJECT TO ALL RIGHTS-OF-WAY AND EASEMENTS OF RECORD.
