COMMENCING AT THE NORTHWEST CORNER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 5 EAST, CRAIGHEAD COUNTY, ARKANSAS: THENCE SOUTH OO°40'15" EAST ALONG THE WEST LINE OF SAID SECTION 28, 1272.62 FEET: THENCE NORTH 88°O6'53" EAST DEPARTIJG SAID WEST LINE, 100.02 FEET TO THE POINT OF BEGINNING: THENCE CONTINUE NORTH 88°O6'53" EAST 1867.89 FEET: THENCE SOUTH OO°43'16" EAST 60.01 FEET: THENCE SOUTH 88°06'53" WEST 1867.94 FEET: THENCE NORTH OO°40'15" WEST 60.01 FEET TO THE POINT OF BEGINNING
