NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS THAT:

SECTION 1: The vehicles and equipment are available from Superior Auto Group of Siloam Springs, AR for \$52,090.87 for an equipped Chevrolet Silverado 1500 Crew Cab and \$51,356.03 for an equipped Dodge Durango Pursuit AWD all up fitted.

SECTION 2: That due to the ongoing supply chain issues and the need to secure these vehicles for the police department to promote the health, safety, and welfare of the citizens of Jonesboro, the City Council in accordance with the terms of A.C.A. Section 14-58-303 hereby waive the requirement of competitive bidding and direct the purchasing agent to purchase the above-described vehicles and equipment for the prices set forth
