## CITY COUNCIL MINUTES - JULY 5, 1983

The Jonesboro City Council met in regular session, Tuesday, July 5, 1983, at 7:30 p.m. Present were Mayor, City Attorney, City Clerk and all aldermen.

The minutes of June 20, 1983, were approved as mailed on motion by Mr. Sanderson, seconded by Dr. Smith. All aye.

The following bid was on review:

A) Vehicle Insurance - Mr. Province moved, seconded by Mr. Mays to accept the bid from Freeze Insurance Agency for \$16,857.00. All voted aye.

The following ordinance was on 2<sup>nd</sup> reading: (601 Krewson)

AN ORDINANCE CONDEMNING A CERTAIN BUILDING IN THE CITY OF JONESBORO, ARKANSAS AS A STRUCTURAL, FIRE AND HEALTH HAZARD; DIRECTING THE CITY ATTORNEY TO TAKE SUCH ACTION AS IS NECESSARY TO RAZE AND DEMOLISH SAID BUILDING; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

A RESOLUTION AUTHORIZING THE MAYOR TO CONVEY CERTAIN REAL PROPERTY BELONGING TO THE CITY OF JONESBORO; AND PRESCRIBING OTHER MATTERS RELATING THERETO

Mr. Hannah moved to adopt the resolution, seconded by Mr. Stricklin. All voted aye. The resolution was given the number 1983:08.
