THE SOUTH 225' OF MATT (CARTER) DRIVE AND THE UNNAMED STREET THAT CONNECTS MATT (CARTER) DRIVE AND BRIAR LANE AS SHOWN ON THE RECORD PLAT OF CARTER SECOND ADDITION TO THE CITY OF JONESBORO AS RECORDED IN THE PUBLIC RECORDS IN JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, ALSO BEING A PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 4 EAST, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
