WHEREAS, Sunflower Social Club, Inc., d/b/a Poppy's Beach Grill & Event Center of Jonesboro has applied for a private club permit to be located at 2915 Kazi, Jonesboro, Arkansas for the purpose of conducting operations on such premises consistent with Arkansas law including, but not limited to, operating a restaurant; and
