FOR SIDEWALK CONSTRUCTION IMPROVEMENTS WHEREAS, the City of Jonesboro has desires to accept the lowest responsible bid and enter into a contract for sidewalk construction improvements;

WHEREAS, the lowest responsible bidder and the firm selected to construct sidewalk improvements is Cameron Construction Co. Inc.;

WHEREAS, Cameron Construction Co., Inc. has bid \$145,586.00 for the construction of sidewalk improvements;

WHEREAS, the funding for the execution of the contract shall come from 07-100-0311-00 and compensation shall be paid in accordance with the contract documents.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1. That the City of Jonesboro shall accept the lowest responsible bid and enter into a contract with Cameron Construction Co., Inc. in the amount of \$145,586.00 for sidewalk construction improvements

Section 2. The funding for the execution of the contract shall come from 07-100-0311-00 and compensation shall be paid in accordance with the contract documents
