Craighead County Jonesboro Public Library public service contract for the purpose of remitting the City's portion of property tax to the Craighead County Jonesboro Public Library
 Craighead County Jonesboro Public Library entered into a public service contract with the City for the purpose of remitting the City's portion of property tax to the Craighead County Jonesboro Public Library and was signed on January 2, 2009. The contract length is from January 1, 2009, to December 21, 2009. The resolution number is RES-09:117 and was approved by the City Council on August 18, 2009.

Craighead County Jonesboro Public Library also entered into a contract with the City of Jonesboro for the purpose of remitting the City's portion of property tax to the Craighead County Jonesboro Public Library for 2011. The length of the contract is from January 1, 2011, to December 31, 2011. The resolution number is RES-10:154 and was approved by the City Council on December 7, 2010.

Craighead County Jonesboro Public Library also entered into a contract with the City of Jonesboro for the purpose of remitting the City's portion of the property tax to the Craighead County Jonesboro Public Library for 2013. The length of the contract is from January 1, 2013, to December 31, 2013. The resolution number is RES-13:016 and was approved by the City Council on March 19, 2013.

Craighead County Jonesboro Public Library entered into a contract with the city for the purpose of remittance of the city's portion of the property tax to the library for 2015. The resolution number is RES-15:038 and was approved by the City Council on April 21, 2015. The contract was signed on May 5, 2015.
