A RESOLUTION OF THE CITY OF JONESBORO, ARKANSAS APPROVING THE IMPLEMENTATION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM CONTRACTS WHEREAS, the City has entered into a contract with the U.S. Department of Housing and Urban Development (HUD), under which HUD has agreed to provide Community Development Block Grant (CDBG) entitlement funds under Title 1 of the Housing and Community Development Act of 1975, as amended; and

WHEREAS, at the Regular City Council Meetings the Jonesboro City Council approved by Resolutions 2004:90, and 2006:27 and by unanimous vote the City's Action Plans for the CDBG Program, in which the Continuum of Care projects were incorporated; and

WHEREAS, the City desires the following Subrecipients to carry out a stated portion of the programs described in its Annual Action Plans;

\$3402.10 each to Continuum members Beacons & Bridges, Crowley's Ridge Development Council, Family Outreach Inc., Hispanic Community Services, Inc. (HCSI), Jonesboro Urban Renewal & Housing Authority HCDO (JURHA), Mid South Health Systems, and Northeast Arkansas Regional AIDS Network (NARAN), and Women's Crisis Center for HUD Projects #62 and #73, City Account Codes 10-0888-0500-62, 10-0888-0500-73;

WHEREAS, the City desires the Subrecipients to carry out and complete the projects described in the Scope of Services; and

WHEREAS, the Subrecipients represent that they have the capacity to do so and are willing to carry out those portions of the Community Development Block Grant program described in its applications and in the Scope of

Services in this AGREEMENT;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS:

Section 1: The Mayor, Douglas Formon and City Clerk, Donna Jackson are hereby authorized by the City Council for the City of Jonesboro to execute all documents necessary to effectuate this agreement.
