Minutes for the City Council meeting October 19, 1981  
CITY COUNCIL MINUTES, OCTOBER 19, 1981

The Jonesboro City Council met in regular session, Monday, October 19, 1981, at 7:30 P.M. Present, Mayor, City Clerk, City Attorney and all aldermen.

The minutes of October 5, 1981, were approved as mailed on motion by Mr. Park, seconded by Mr. Hannah and all council voting aye.

Mr. Harry Moore, Attorney, addressed council concerning the MAPC decision on Indian Valley Subdivision. Mr. Sanderson moved that a hearing on the appeal be held on November 2, 1981, at 6:30 P.M. Motion seconded by Mr. Hinson, all aye.

Mr. Park offered the following resolution:

Mr. Hannah moved for the adoption of the resolution, seconded by Mr. Stricklin, all aye. The resolution was given the number 1981:16.

The following ordinance was on 2<sup>nd</sup> reading:
