Minutes for the City Council meeting on January 17, 1955

The City Council of the City of Jonesboro, Arkansas met in regular session on the above named date in the City Hall. There were present: Mayor, City Clerk, City Atty., and the following named Councilmen: Mr. Powell, Mr. Hamilton, Mr. Stricklin, Mr. Hall, Mr. Snow, Mr. Copeland, Mr. Hendrix, Mr. Kaffka, Mr. Taylor. Absent: Mr. Johnson.

Mr. Stricklin offered the following Ordinance:

AN ORDINANCE TO CREATE AND ESTABLISH A CITY PLANNING COMMISSION OF THE CITY OF JONESBORO, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

Mr. Hendrix made the motion, seconded by Mr. Hall, that the rules be suspended and the ordinance be placed on the second reading. Roll was called, all members voting aye. The Ordinance was then read for the second time. Mr. Hendrix then made the motion, seconded by Mr. Hamilton, that the rules be suspended and the Ordinance placed on the third and final reading. Roll was called, all voting aye. The ordinance was then read for the third and final time. Mr. Stricklin made the motion that the ordinance be adopted as read. Mr. Taylor seconded the motion. Roll was called. All voting aye. Motion carried. The roll was then called on the emergency clause. All members voting aye. The ordinance was given the number 894.

Mr. Powell offered the following resolution:

Mr. Hendrix made the motion, seconded by Mr. Stricklin, that the resolution be adopted as read. Roll called. All aye. Motion carried. The resolution was given the number 1955:03.

Mr. Hendrix offered the following Ordinance:

The roll was then called on the emergency clause. Nine voting aye. Mr. Powell no. The ordinance was given the number 893.

Mr. Taylor made the motion, seconded by Mr. Copeland, that the purchase of Water Fountains be referred the building and plumbing committee with request for bids and make recommendations to the next regular meeting. Roll was called. All aye.

Mr. Stricklin made the motion, seconded by Mr. Hamilton, that the bills as okayed by the Finance Committee be paid. Roll was called. Motion carried.

Mr. Hamilton made the motion, there being no further business that Council adjourn. Mr. Taylor seconded the motion. All aye. Motion carried. Council Adjourned.
