Minutes for the City Council meeting on May 18, 1992 CITY COUNCIL MINUTES - MAY 18, 1992

The Jonesboro City Council met in regular session a 7:30 p.m. Present were the City Clerk, City Attorney, and all the Alderman with the exception of Mr. Evans and Mr. Province who were unable to attend. Mr. Hinson, Vice Mayor, presided over the meeting in the absence of Mayor Brodell, who was away on official business.

The minutes of May 4, 1992, were approved as mailed by motion of Mr. Stricklin, seconded by Mr. Shelton. All voted aye.

Mr. Stricklin offered the following ordinance for the first reading:

AN ORDINANCE AUTHORIZING PAYMENT TO CITY WATER & LIGHT FOR MATERIALS USED IN WIRING THE SOUTHSIDE SOFTBALL COMPLEX WITH ELECTRICAL LIGHTING.

Mr. Stricklin moved, seconded by Mr. Hannah to suspend the rules and place on second reading. All voted aye. Mr. Stricklin moved, seconded by Mr. Hannah to further suspend the rules and place on the third and final reading. All voted aye. Mr. Stricklin moved, seconded by Mr. Mays for the adoption of the ordinance with the emergency clause. All voted aye. The ordinance was given the number 2399.

Mr. Shelton offered the following ordinance for the first reading:

AN ORDINANCE TO AMEND ORDINANCE NO. 954 KNOWN AS THE ZONING ORDINANCE PROVIDING FOR THE CHANGE OF ZONING BOUNDARIES.

Mr. Nix moved, seconded by Mr. Wise to suspend the rules and place on the second reading. All voted aye. Mr. Sanderson moved seconded by Mr. Mays to further suspend the rules and place on the third and final reading. All voted aye. Mr. Sanderson moved, seconded by Mr. Nix to adopt the ordinance with the emergency clause. All voted aye. The ordinance was given the number 2400.

Mr. Hannah offered the following ordinance for the first reading

AN ORDINANCE TO AMEND ORDINANCE NO. 954 KNOWN AS THE ZONING ORDINANCE PROVIDING FOR THE CHANGE O F ZONING BOUNDARIES.

Mr. Sanderson moved, seconded by Mr. Nix to suspend the rules and place on the second reading. All voted aye. Mr. Sanderson moved, seconded by Mr. Nix to further suspend the rules and place on the third and final reading. All voted aye. Mr. Sanderson then moved, seconded by Mr. Stricklin for the adoption of the ordinance with the emergency clause. All voted aye. The ordinance was given the number <u>2401</u>.

The following ordinance was on the third reading:

AN ORDINANCE TO APPEAL DECISION OF M.A.P.C. TO REZONE PROPERTY FORM R -3 TO C-3 OWNED BY MR. ROGER PRESLEY.

Mr. Shelton moved, seconded by Mr. Stricklin to deny the ordinance on grounds it would be spot zoning. A roll call was taken which resulted in a nine to one vote in favor of the motion. All aldermen voted aye with the exception of Mr. Wise who voted nay.

The following bid was up for review: -92:26 Street /Sanitation for hydraulic fluid and motor oil. Mr. Hannah moved, seconded by Mr. Nix to accept the lowest bid which meets low bid specifications. All voted aye.

Under new business Mr. Bridger moved, seconded by Mr. Stricklin to approve the expenditure of \$19,860.00 to purchase 40 new helmets, 60 personal motion-heat detectors for firemen and renovation of a fire truck, with funds to come from the appropriated funds in the general budget.

Mr. Lowes, at Aldermen Jerry Mays request, gave a report on the success of the recycling program and encouraged all to participate.

With no further business the meeting was adjourned.
