AN ORDINANCE ADOPTED PURSUANT TO ACT 1112 OF 2017 AND APPLICABLE ABC REGULATIONS APPROVING THE PRIVATE CLUB APPLICATION FOR MALCO HOLLYWOOD CINEMA AT 2407 E. PARKER ROAD, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS. WHEREAS, Act 1112 of 2017 requires applicants for private club license obtain approval of the governing bod y of the city or county where the private club is to be located; and

WHEREAS, MALCO HOLLYWOOD CINEMA has made proper application with the City of Jonesboro for a private club at 2407 E. Parker Road, Jonesboro, Craighead County, such application received by the Jonesboro Police Department.

WHEREAS, the City Council of Jonesboro, Arkansas, has reviewed the application of MALCO HOLLYWOOD CINEMA and finds it meets the requirements of law; and

NOW, THEREFORE, be it ordained by the City Council of Jonesboro, Craighead County, Arkansas:

Article I. That the private club application of MALCO HOLLYWOOD CINEMA for issuance of a private club license at 2407 E. Parker Road, Jonesboro, Craighead County, Arkansas, be, and it hereby is, approved by the C ity Council of the Jonesboro, Craighead County, Arkansas.

Article II. That pursuant to Act 1112 of 2017, MALCO HOLLYWOOD CINEMA. is hereby authorized to file a private club application with the, Department of Finance and Administration, Alcoholic Beverage Control Division, for the location at 2407 E. Parker Road, Jonesboro, Craighead County, Arkansas. A copy of this Ordinance shall be provided to the Alcoholic Beverage Control Division, Department of Finance and Administration along with the ABC private club application of MALCO HOLLYWOOD CINEMA.
