LEGAL DESCRIPTION: NORTHWEST ADD

WHEREAS, ALMA LETICIA AND NICHOLAS MATA, the owner of record, was properly notified of a code violation at NORTH THIRD, PARCEL NUMBER 01-144182-22000 Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and,

WHEREAS, the code enforcement officer corrected the code violation using city funds in the amount of \$915.00; and,
