WHEREAS, DKI LLC C/O RICHARD KNIGHT, the owner of record, was properly notified of a code violation at 1328 W Huntington, Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and,
