A RESOLUTION OF THE CITY OF JONESBORO TO ENTER INTO AN AGREEMENT WITH THE HISPANIC COMMUNITY SERVICES CENTER, INC. FOR THE CDBG PUBLIC SERVICES PROGRAM.

WHEREAS, the City of Jonesboro, Arkansas, has allocated FY20 21 CDBG Program funds for the HISPANIC COMMUNITY SERVICES, Inc. to receive \$20,000 for its "LA ESCUELITA" AFTERSCHOOL Program to assist K-8th grade individuals with tutoring; and,

WHEREAS, the City desires the subrecipient to carry out its stated objectives for the public services program as prescribed in the CDBG Annual Action Plan and in the scope of services within the said agreement; and,

WHEREAS, the sub recipient assumes responsibility for administering Federal funds in a manner consistent with underlying agreements, program objectives, and the terms and conditions of the Community Development Block Grant Program as described in this agreement.
