BEGINNING AT THE SOUTHWEST CORNER OF LOT 1, BLOCK 3 OF PATRICK'S 1ST ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE NORTH 00°08'21" WEST, ALONG THE WEST LINE OF SAID LOT 1, 11.81 FEET; THENCE SOUTH 89°51'23" EAST, LEAVING SAID WEST LINE, 423.14 FEET; THENCE SOUTH 00°42'41" EAST, 7.87 FEET TO THE SOUTH LINE OF SAID BLOCK 3; THENCE SOUTH 89°36'34" WEST, ALONG SAID SOUTH LINE, 423.22 FEET TO THE POINT OF BEGINNING, CONTAINING 4,164 SQ.
