AN ORDINANCE TO AMEND THE SECTION 2-95 TO ADD THE A&P COMMISSION AND THE PACE COMMISSION TO THE LIST OF COMMITTEES/COMMISSIONS THAT MAY SUBMIT MATTERS DIRECTLY TO COUNCIL WITHOUT REQUIRING ANOTHER COMMITTEE REVIEW

WHEREAS, the City Council of the City of Jonesboro, Arkansas has established its rules of operation in the Code of Ordinances, and

WHEREAS, the Section 2-95(b)(3) designates which committees/commissions may bring legislation directly to the full council without the requirement of another committee approval; and

WHEREAS, the City Council for the City of Jonesboro desires to add the A&P Commission and the PACE Commission to this list of committees/commissions.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JONESBORO,

ARKANSAS:

SECTION ONE: That Ordinance 2-95(b)(3) shall be amended to add the A&P Commission and the PACE Commission to the list of committees/commissions that may take legislation recommended by them directly to council without requiring another committee's approval.

SECTION TWO: Should any prior ordinance or legislation conflict with this ordinance it is hereby repealed to the extent of said conflict.
