A RESOLUTION BY THE CITY OF JONESBORO, ARKANSAS TO ACCEPT THE LOW BID AND ENTER INTO A CONTRACT WITH ALL SCAPES IRRIGATION & LAWN CARE LLC FOR THE CRAIGHEAD FOREST PARK FISHING DOCK REBUILD PROJECT (2022:28)

WHEREAS, the City of Jonesboro desires to accept the low bid and enter into a contract for the Craighead Forest Park Fishing Dock Rebuild project;

WHEREAS, the low bidder and the firm selected for the project is All Scapes Irrigation & Lawncare LLC; and

WHEREAS, funding for the execution of the contract shall come from Capital Improvement budget and compensation shall be paid in accordance with the agreement.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS;

Section 1: That the City of Jonesboro shall accept the low bid and enter into a contract with All Scapes Irrigation & Lawncare LLC for the Craighead Forest Park Fishing Dock Rebuild project.

Section 2. That funding for the execution of the agreement shall come from Capital Improvement budget and compensation shall be paid in accordance with the agreement.

Section 3. The Mayor and the City Clerk are hereby authorized by the City Council for the City of Jonesboro to execute all documents necessary to effectuate this contract.
