LEGAL DESCRIPTION: A part of Lot 2 and a part of Lot 4, Block "C" of Nisbett's First Addition to the City of Jonesboro, and Part of Lot 1 of the Miles Replat of the East Half of Lot 4 and the West 64 feet of Lot 3, all being in Block "C" of Nisbett's First Addition to the City of Jonesboro, said Replat being shown by Plat Cabinet "C" Page 82 at Jonesboro, lying South of an existing fence, both being a part of Nisbett's First Addition to the City of Jonesboro, Arkansas, and being more particularly described as follows: From the Southeast Corner of the West 39 feet of Lot 1, Block "C" of said Nisbett's First Addition; thence North 90° 00' 00" West a distance of 46.32 feet to the point of beginning; thence North 90° 00' 00" West a distance of 53.51 feet to a point; thence North 00° 34' 28" East a distance of 96.72 feet to a point on a fence; thence South 89° 48' 56" East along a fence a distance of 60.46 feet to a point; thence leaving said fence, run South 00° 58' 22" West a distance of 27.74 feet to a point; thence South 35° 45' 35" West a distance of 12.52 feet to a point; thence South 00° 07' 45" West a distance of 58.63 feet to the point of beginning, subject to easements and rights of way of record, AND being subject to an Ingress/Egress Easement more particularly described as follows: A part of Lot 2, Block "C" of Nisbett's First Addition to the City of Jonesboro, Arkansas, more particularly described as follows: From the Southeast corner of the West 39 feet of Lot 1, Block "C" of said Nisbett's First Addition; thence North 90° 00' 00" West a distance of 46.32 feet to the point of beginning; thence continue North 90° 00' 00" West a distance of 6.00 feet to a point; thence North 00° 07' 45" East a distance of 58.72 feet to a point; thence South 89° 08' 45" East a distance of 6.00 feet to a point; thence South 00° 07' 45" West a distance of 58.63 feet to the point of
